- (b) the licensee must not incur costs of more than £50,000 per annum for the purpose of carrying out activities authorised by the licence.

- (iii) through intermediaries other than the licensee, or with a person other than the licensee who is either the holder of a remote general betting (standard) operating licence, or provides facilities for remote betting, the arrangements for which are subject to the law about gambling of an EEA state, Gibraltar or a country or place specified in regulations made under section 331(4) of the Act, and
- (iv) in circumstances where the licensee is not a party to any bet made or accepted by the persons referred to at (i) above;

the licensee's annual gross gambling yield is less than £550,000.
